Survey of Likey Oregon Voters on Measure 88 (Driver Cards)

Conducted: 8/14/2014 through 8/20/2014

Survey Type: Live Agent

N = 401

Margin of Error at 95% Confidence Level: +/- 4.8%

Weighting Applied: Gender, Age, Poltilical Party Registration

Q1) This November Oregonians will vote on a referendum that if passed, would "Provide Oregon resident "driver card" without requiring proof of legal presence in the United States. The result of "Yes" vote would direct the Department of Transportation to issue "driver card" to Oregon resident meeting specified eligibility, without requiring proof of legal presence in United States. The result of a "No" vote would reject the law and not issue driver cards.

Q3) Next, I'd like to read you more details about the referendum. Current Oregon law requires any applicant for an Oregon driver's license or permit to provide proof of legal presence in the United States.

The measure directs the Department of Transportation to issue a "driver card" to an applicant who does not provide proof of legal presence in the United States, but who has otherwise complied with all Oregon requirements for the type of driving privileges sought, has provided proof of residence in Oregon for more than one year, and has provided proof of identity and date of birth.

The driver card may not be used as identification for air travel, to enter a federal building, to register to vote or to obtain any government benefit requiring proof of citizenship or lawful presence in the United States.
